1,311 ballots were mailed by the American Arbitration Association to eligible voters on 7-24-2020. The ballot mailing was originally scheduled for 3-16-2020 but was delaved due to the COVID-19 Pandemic and executive orders issued by the State of Illinois and the City of Chicago which limited the number of people allowed to gather in one place indoors. When the state entered Phase 4, allowing gatherings of up to 50 people, the ballot mailing was held on 7-24-2020. 520 ballots were returned out of the 1,311 mailed out. We have another election on 11-3-2020. Vote!!!

Get Involved...

We had some new and younger candidates who ran for office this time. which is encouraging. Two of the offices with younger candidates were the Maintenance Director and the Vice President. These offices are grievance handling positions so it would help to get some Steward experience first. The Secretary job is not a grievance handling position but most of our Secretaries were also Stewards. As senior Stewards retire we will be soliciting to fill those Steward positions. If you are serious about being involved and think you can learn as you go, you might want to apply. We normally post a letter when we have a Steward vacancy and to apply the member writes a letter to the president stating they are interested in the job. The job is not for everyone but we do have many long-serving Stewards. That is the way all of the current officers started with the union. They became Stewards and stuck around long enough to learn the contract and how the union works. You never stop learning as a Steward but we all had to start at the beginning...

Most received their retro-active pay on paychecks dated 9-4-2020 but 2000 employees nationwide did not because they were either in a saved grade or in a salary exception. Salary exceptions applied to the MVS craft and Accounting Services is working to manually input their back pay. The retroactive pay period is 9-20-2018 through 4-20-2020. The amount an employee receives is based on the actual work hours, step and level, overtime hours worked, premium pays, and paid leave hours. No pay is received for LWOP. Retirees who were still working during the retro-pay period will receive a check for the hours owed. Contact the union if you did not get your retro-pay.

AL Carryover 2021

The amount of annual leave that can be carried over into 2021 is increased from 440 hours to 520 hours. Employees can still sell back a maximum of 80 hours of annual leave prior to the beginning of leave year 2021 provided:

- 1. The employee must be at the maximum leave carryover ceiling at that the start of the leave year; and
- 2. The employee must have used fewer than 75 sick leave hours (excluding emergency sick leave taken under the Families First Coronavirus Act in leave year 2020. This MOU expires on 12-31-2020.

General Expediters

National Clerk Craft Director Lamont Brooks followed up with the USPS on rumors of Expediters being assigned to Motor Vehicle. He states certain employees may report to a different supervisor based on a Headquarters realignment dealing with logistics and transportation. The restructure could affect more than General Expediters. Such employees will remain in their current craft.

Automation Clerks to Return to 0700 and 1500 at Palatine...

Management offered some tour 2 and tour 3 Automation Clerks the option to change their time later by 4 hours to 1100 and 1900 or become unassigned. No choice! These were not the most senior Clerks in their sections but they were not the most junior either. The most junior were excessed out of the section and the next senior had their jobs reposted, some to the later 1100 and 1900 times. Because of the excessing out of the section there was closed section bidding for both tours. Then on 7-9-2020 management informed the Union that the Awards for tour 2 and tour 2 Automation was cancelled and all affected Clerks would be returned to their original bids. They also said this did not include the time changes. Many of the Clerks moved to the later 1100 and 1900 start times were senior to Clerks who were returned to their bids when management canceled the Award. The Union filed a grievance for the denial of bidding and seniority rights on 7-16-2020 and has been in discussions with management since that time. The grievance was resolved on 9-2-2020 to return all Automation Clerks back to their original 0700 and 1500 start times on 9-12-2020.

Carol Stream Automation

Recently I spoke with two tour 3 Automation Clerks who asked why they could not go back to 1600 after being moved to 1700. I contacted the plant manager who responded: "After looking at the volumes, it has been determined to leave them at the 1700 start." I will request to see what volumes they are looking at to see if we have an argument for a 1600 start. Management has the right to schedule and staff but the union can and should make efforts to gain better schedules if we can.

You have 14 Days to File...

Grievances must be filed within 14 days of when the grievant or the union becomes aware. That does not mean that the grievant has 14 days and the union has another 14 days. It means if you get a Letter of Warning or a Letter of Demand, or are bypassed for OT or holiday work, you have 14 days to have a grievance filed for you. This is especially true if you are off work and mailed discipline. Whatever is going on in your life, it is always worse without a job, so call the union and let us know. When the union is notified of a bid reversion or whatever it might be, we have 14 days to file from when we became aware. When the grievance is filed untimely it does not matter how good a case we have, if management sees that it is untimely, its going no where. If you have no Steward in your office or no one answers in the Union room you can call the Union Hall at 630-833-0088 and let me know so we can get it filed. If you need to file a grievance or you think your rights have been violated you should request a Steward and should be able to speak to one in 2 hours or less. If they say they called the Union room and no one answered but vou know there is a Steward working in their unit then management must get the Steward up. Most times there is at least one Steward in the building on any day and tour, but they are working on the floor, and not released. Last Call for Scholarships...
