Vote!!!

We are less than one week from election day and we all need to vote. The fate of the USPS hangs in the balance... I voted by mail and it only took 6 days for the ballot to go from the Northlake Post Office to the County Clerk's office in downtown Chicago as I was emailed yesterday to confirm the receipt of my ballot! **COVID Cases Rising** I thought Palatine had the most cases in the Chicago area, but I recently spoke to President James Malone of the South Suburban Local about 2 weeks ago and he said they had 53 cases at South Suburban. Last count Palatine was at 42 confirmed cases. The Carol Stream Plant Manager will notify both unions of any new positive cases at CS but she does not give a total. Lakeland is the only District that puts out a weekly updated list online of all offices so you know the numbers. The other districts should do the same. Masks to be given out We will be giving out an APWU mask to all our members very soon.

You can thank Palatine clerk Linda Rowland for this idea as she would consistently ask me for a union mask every time I saw her for some months. After the election I made a suggestion that we buy masks for our members. I waited until after the election to do this so I could not be accused of trying to buy your vote. We now know how important wearing masks is to keeping us all safe. Stay safe and thank you to all of our members. **National RI-399 Cases** Three national RI-399 disputes are scheduled to be arbitrated as follows: AFCS, December 2020 ADUS, January 2021 USS, February 2021 Carol Stream P&DC has **Automated Canceller** Facers which are staffed by Clerks since late 2012, when they deployed the AFCS-200, and upgraded these machines to cancel, face, and sort letter mail. The AFCS dispute was filed by the Mailhandler Union and is the first time in my recollection that work was taken from them and assigned to us. That was unheard of, as work is usually taken from Clerks and assigned to Mailhandlers. A first!

Lets hope we hold onto it. ADUS is short for Automated Delivery Unit Sorter and this machine was first tested in post offices with large parcel volume and not in the plants. The post offices have no MHs so there would be no MH staffing on an ADUS in a post office. The dispute is in the plants where MHs have been assigned to the functions of staging mail, sweeping and dispatching. While most of the work on COVID Cases Rising the ADUS was assigned by USPS to Clerks, a dispute was filed by APWU to say that the functions assigned to Mailhandlers should be assigned to Clerks as an integral part of the operation, in offices that have Mailhandlers. The Mailhandler Union has also filed a dispute on the ADUS machine. The USPS has created a monster by pitting Clerks against Mailhandlers so they can fight over work. The third case is for the Universal Sorting System, which is nothing but a mechanical Parcel Sorter where the employee has to Email: nwial7140@yahoo.com distribute or sort the mail by zip to right container. This is distribution but that did not stop USPS from giving it to MHs. We know its Clerk work.

Mailhandler Award on noncareer discipline into career

The unions have been arguing this since the creation of non-career employees, MHA/PSE, with union rights in the 2010-2015 contract. There was nothing put in the contract stating that non-career employee's discipline record will be cleaned when they become career. The simple argument is that this is a new (career) appointment so the record should be clean but this was not agreed to in the contract. We argued it but management continued to cite discipline issued to non-careers in discipline issued to a new career employee. Since the non-career employee is not always afforded the full range of progressive discipline it seems unfair to not clean their record when they are hired as career. National Arbitrator Shyam Das agreed with the Mailhandler Union that the non-career is a new hire when converted to career and their discipline record is clean. That is victory for all MHAs and PSEs and the end of a long fight. Cameras on the Window... Melrose Park has new monitors with cameras on them and we were asking is this Big Brother, but it turns out all new monitors have cameras on them for Zoom. Clerks were concerned that management was using the new monitors to spy on Clerks while they are working, but I was told by the national union that cameras are automatic on new monitors and we can put tape or a post-it over it. Clerks had already figured it out. Window Clerk Safety

In the race to cut Clerk jobs some offices that normally have at least two clerks on the window are staffing with one, leaving one clerk alone should there be any kind of trouble. This is the case in Northlake where there have been robberies along North Avenue.

The window needs to be secure, with the entire window covered with plexi-glass so the clerk is not at the mercy of anyone coming in with the intent to do harm or steal. Currently the window has a plastic shield for each station but anyone could come over the counter... At least with two Clerks one could call for help in case of emergency but one Clerk and no protection is a sitting duck. All they say is we have clerks off and the office does not earn two Clerks from this time to this time. Secure the window! **Update Contact Information** Recently a Palatine Clerk collapsed at the time clock and was taken to the hospital where she remains today on life support. We hope for a miracle for her. Steward and Safety Captain Johnny Love Sr. called to ask me to urge employees to update their contact information at the post office in case of an emergency. Management will contact your emergency contact but they need to have the correct information. Please make sure your emergency contact information is updated. Johnny also advises employees to "ICE" your phone, which he states is simply placing I.C.
