## **Glenview shake-up**

As you are aware, for a while now, Jackie has written in the Local Line how abusive and toxic management at the Glenview facility has been. Both Jackie and I have been contacting the POOM about having a Climate assessment performed there and also letting the POOM know about employees issues there. On Wednesday, February 7, I received an email from an employee notifying me that the postmaster (Narbi Miulli) and manager (Santos Perez) were removed that morning. I immediately made phone calls to investigate this issue. The email was confirmed. Upon further investigation I have found out that not only were both removed, they were also both demoted. The abusive and toxic postmaster was demoted to supervisor at the Huntley post office and the hatchetman Manager was demoted to supervisor at Mundelein. Neither of these offices

are in our Local.

Hopefully, both will have learned a lesson, but I doubt it. Both managed as if the employees were chattel. What I really wish for is that the supervisors remaining at Glenview, having the dark cloud of the postmaster and manager removed, will allow light to once again shine on the Glenview facility and treat the employees with the dignity and respect they deserve.
