President's Task Force (Per Postalreporter.com) The President's Task Force on the USPS will make recommendations on "reforms" in August. It comes as no surprise that the result of Trump's task force reform plan is to privatize the USPS. This would allow USPS to follow private sector practice in compensation and labor relations and opt out of federal benefit programs which we now participate in such as the Federal Employee Benefit Health plan and the Federal Employee Government Life Insurance. USPS privatization through an initial public offering (IPO) or sale to another entity would require the implementation of significant reforms prior to the sale to show a possible path to profits. Most foreign post offices that have been privatized have been profitable at the time of sale while they say USPS has lost 65 billion since 2008. That figure is misleading as \$50 billion is for prefunding retiree health care benefits 75 years into the future per the

which crippled the USPS.

To reach profitability they say USPS would have to restructure and reduce the workforce and services. They say the existing unfunded liabilities in USPS retirement programs total more than \$100 billion and that USPS owes an additional \$15 billion to Treasury's Federal Financing Bank and also has liabilities to the Department of Labor's Workers Compensation program. According to USPS own estimates, the Agency is insolvent with liabilities exceeding assets by more than \$120 billion. In some cases foreign governments have absorbed legacy retirement liabilities in order to sell their post offices. This is not a Done Deal! Any plan to privatize the USPS would have to pass the House and Senate. Trump would sign a bill to privatize but it would have to pass the congress first. APWU Drops RI-399 Disputes Most of our newer members have probably never heard of RI-399, which is Regional Instruction 399 but stands for a whole lot more. It is a very old document (1978) containing guidelines which are used by the Postal Service to determine which craft, Clerks or Mailhandlers should perform work in mail processing facilities. These guidelines were to be used to establish positions and make assignments between these crafts. Clerks were identified as the primary craft to perform distribution. The RI-399 is even found in the back of the Mailhandler contract. **Distribution** is defined in the USPS M-32 handbook as follows: "A sortation of mail to ADC's states, sectional centers, cities, foreign countries, branches, carrier routes, hold outs (for example, firms, addresses, institutions, boxes) box sections, ZIP codes, uncoded mail, Nixie, APO, FPO, or similar separations. Any sortation by size, shape, weight, class, or facing of mail is not distribution." Mailhandlers were identified as the primary craft to perform the functions, which are ancillary to the Clerk activities, such as culling and transporting of the mail. For Clerks in the plants there has been no bigger threat to our work than the USPS giving Clerk work to the Mailhandler Craft and the MH Union always trying to take our work nationally and locally. Think of the Low Cost Tray Sorters for distribution of tubs/trays, or the Incoming Parcel Post unit which they tried to claim at Carol Stream and Palatine although the RI-399 says this is Clerk work. For some reason USPS gives Clerk work to the Mailhandlers. I don't know if its because they are level 4 and Clerks are level 6, or if its because of penalty V pay, but with all the OT called for MHs the USPS can't be saving money.

National Level Disputes...

Most of the national level craft jurisdictional disputes were filed by APWU after USPS gave most of the work on the AFSM-AI and FSS to Mailhandlers with Clerks retaining very few Flatsorter jobs. When I started in 1976 Clerks had most of the work, we keyed letters on the LSM, we keyed flats on Flatsorter (881s), and still worked mail in the manual units on the belts, in the cases, and in the tubpack and traypack units where travs were distributed by zip to containers for dispatch. When the LSMs were replaced by OCRs and DBCS machines the Mailhandler Union at the national level filed a dispute saying this was MH work. This dispute file by the MH union went to arbitration and the work was retained by the Clerk craft. The MH position was that the-OCR machine was performing the distribution, not the Clerk, and it was a feeding sweeping operation. Automated distribution of letters in the OCR and DBCS was Clerk. The AFSM automated the sorting of Flats and work on the AFSM was assigned to the Clerk craft. On the mechanized 881 Flatsorter the Clerk prepped the mail on the machine so there were no MHs. USPS created a prepping unit for the AFSM and assigned it to MHs who removed plastic from bundles and placed the mail into the carts. With the addition of Automatic Induction on the AFSM feeders USPS combined prepping and feeding on the machine and assigned it to MHs. Clerks retained the feed station and sweeping, but at Palatine they added the ATHS, Automatic Tray Handling System which pushed the tubs out automatically and replaced the Clerk. CS never got the ATHS and did not lose as much work on AFSM. Most work on the FSS was assigned to MHs as prepping but it was really prepping and feeding.

National APWU Disappointing The APPS (Automated Package Sorting System) replaced the SPBS machine in 2004 and local disputes were filed at Busse and Palatine to be held pending the national dispute. Palatine lost the APPS in 2007 and got if back in 2017 and the dispute sat there. We call RI-399 the "black hole" because when you file a dispute it iust sits there because the USPS and the other Union do not want to change the craft assignments. When these disputes are arbitrated the moving party usually loses as the arbitrator agrees with USPS. I guess this is why the APWU at the national level decided to sign a Memorandum of Understanding agreeing to withdraw most of the disputes filed before 9-11-2017 unless craft jurisdiction was in consistent with the RI-399. I do not agree with this action because it does not benefit our members. It only benefits the MH Union and the USPS for taking Clerk work. If you are a PSE and want to know why MHAs get turned over faster it is because USPS has used operational changes or new work to transfer Clerk work to the MHs. I called National Assistant Clerk Craft Director Lynn Pallas-Barber to tell her what I thought of this. She said "We didn't think you would be happy" and I said "Do you think I am the only one?" Our members have a right to be informed, good, bad or otherwise. In my opinion this was bad for APWU and good for the others. USPS gets to give Clerk work to the MHs and years later APWU signs a document in agreement. I am disappointed in our national President, Mark Dimondstein for signing this and in Lynn Pallas for helping to negotiate a total surrender in the fight for Clerk work. The only good point is that work formerly performed by MHs in the AO's is agreed to be Clerk work.
