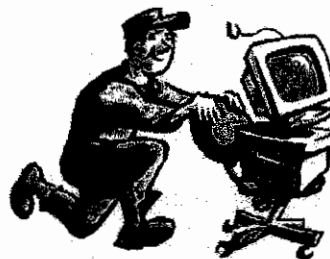

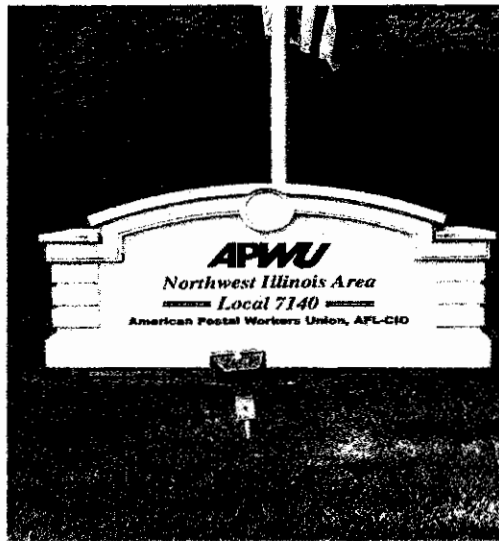

DIRECTIONS TO THE NWIAL UNION OFFICE IN ELMHURST

From the East

Take 290 West. Pass the exit for Route 20 Lake Street East. Get off on the exit for Route 20 Lake Street West. Turn left at the first stoplight, which is Walnut street. Turn left immediately onto Lake Street frontage road. Go down 3 blocks to 194 West Lake Street.

From the North

Take 294 South to the 290 West / Route 64 exit. Follow 290 West to the second exit, which is Route 20 Lake Street West. Turn left at the first stoplight, which is Walnut street. Turn left immediately onto Lake Street frontage road. Go down 3 blocks to 194 West Lake Street.

From the South

Take 294 North to 290 West. Pass the exit for Route 20 Lake Street East. Get off on the exit for Route 20 Lake Street West. Turn left at the first stoplight, which is Walnut street. Turn left immediately onto Lake Street frontage road. Go down 3 blocks to 194 West Lake Street.

From the West

Take 290 East to York Road. At the end of the looped exit, you will come to a stoplight, which is York road. Go straight through the stoplight. At the next stoplight, go straight again, as the road veers to the left. The next stoplight is Walnut street. Turn left on Walnut street. Turn left immediately onto Lake Street frontage road. Go down 3 blocks to 194 West Lake Street.
