Staples Protests... On 4-24-14 we protested at Staples in Schaumburg and Hillside. Unfortunately most other Locals and most of our members did not bother to participate. The national day of action was an effort to call attention to the deal between Staples and the Postal Service to transfer Retail work and jobs from postal employees to Staples employees who make less \$. Our national President is an activist and he thinks he can get postal workers to show up when needed but very few showed up. We had about 30 people in Schaumburg and maybe a few more in Hillside. We also had about ten people from a group called "Communities and Postal Workers United" who heard about the protest and picketed with us. These were non-postal workers who showed up to carry a picket sign while APWU members did not bother to come. Saving the Postal Service depends on getting public support for maintaining it as a public service against the forces of privatization. The last big postal strike was in 1970 so today's postal workers have never had to walk a picket line.
